"God Save the King! King save the gold!"

In the specific case of its gold reserve deposited in the Bank of England, it is the reason why the Venezuelan people can sing to Carlos III "... God save the King! Let him be victorious against usurpers. May he have nobility to restore our gold to us. May he have a long reign and we health and food thanks to our gold. God save the King!



"God save the King!" chant the British to celebrate their new King. In Venezuela, it inspires to add "! King save the gold!"

Easy to understand remembering English pages of History and contemporary Venezuelans. If the history of the United Kingdom is projected to the whole world, the mainstream media are more discreet to present some contemporary facts when England and others appropriate assets of the Venezuelan State.

Charles III has just ascended the throne as successor to his recently deceased mother Queen Elizabeth II. Of course, it is to be desired that God will take care of the king and that the queen will rest in peace.

Whether England is a monarchy is the exclusive business of its citizens, as of the other ten European nations with royalty as they are, in alphabetical order: Belgium, Denmark, Spain, Liechtenstein, Luxembourg, Monaco, Norway, the Netherlands and Sweden.

In honor of their new King the English sing "God Save the King!" England does not have an official national anthem and uses this chant between two others. In 1714, the German composer of Silesian origin Georg Handel presented this song to King George I, the monarch adopted it and in 1745 it became the anthem of the royal family, the British Empire and its colonies.



Thus, his subjects sing to Charles III "... God save our glorious King. Long live our noble King. May he be victorious. Happy and glorious. May he have a long reign over us. God save the King."

May God save the king, the people of Venezuela desire, but also save the gold that belongs to him.

His Majesty must save this gold threatened to be stolen by thieves to share this juicy booty. They are 31 tons of gold valued at 2,000 million dollars that in 2008 the Venezuelan Government entrusted to the custody of the Bank of England.

But His Majesty should also know that:

- Your government, in an interventionist way, decided to recognize as president of Venezuela a certain Guaidó, self-proclaimed "interim president", ignoring its legitimate president Nicolás Maduro, democratically elected by an absolute majority of its citizens.
- The "interim president" was born in Washington where during a visit the then Secretary of Foreign Affairs of the United Kingdom Jeremy Hunt interviewed by the mainstream media declared "The UK believes that Juan Guaidó is the right person to take the reins of Venezuela. We support the United States... for that to happen"; pretext of the Bank of

England in 2020 to turn custody into kidnapping and its Supreme Court administrator of these reserves, complicit in strategies to destabilize Venezuela.

There is no doubt, confirmed by many official statements, that the US and allies at its service aim to destabilize Venezuela through sanctions against its people in order to overthrow its government and impose another at its convenience. A simple "remake" of numerous antecedents achieved with incitements to coups d'état or even assassinations of presidents in direct or covert actions. Recently, Venezuela witnessed several attempts at mercenary landings and assassination of the president, all with the participation of the United States and its then complicit allies and authorities of Colombia.

In 2022 Venezuelan parties voted to remove the "interim president", but gold is still sequestered in the Bank of England.

The situation of Venezuelan gold reserves is actually a simple example of the behavior of the great powers. It is, through sanctions against weaker countries, to demonstrate to the world that they command and impose even their "own" concepts of justice.

Venezuela is currently suffering several cases, all imposed by the US and some countries of the European Union, which demonstrate them:



The Presidency of Venezuela: One of the pretexts and justifications of the behavior of the US and its allies for those cases are as grotesque as illegal. They simply give themselves the right to decide for themselves who should be the president of Venezuela. The US imposed the existence of a certain Juan Guaido as "interim president who proclaimed himself". For this, of course, they ignore the presidential elections of Venezuela of 2018, their results announced by their CNE National Electoral Council, the recognition of hundreds of international observers and mainly the 6,248,864 Venezuelan citizens who with 67.84% of the votes re-elected Nicolás Maduro as their president for the period 2019-2025 against their closest other candidate, which only achieved 20.93% of votes.

So since 2019, but without any proof they invent an alleged electoral fraud. The United States and other governments, including the British government, decide for themselves that the legitimate president of Venezuela is called Juan Guaido, coincidentally an excellent accomplice to achieve spoils.

The gold kidnapped in England: No sensible person can think that England really needs to hoard the gold reserve that Venezuela deposited in its bank, which its new king showed the world by presenting his riches using for his coronation a carriage estimated at more than 3.6 million euros with its 2.75 tons in gold, diamonds and other precious stones, although some wonder how many countries England has plundered to have so much wealth?... although the celebrated writer Oscar Wilde wrote that "England has never created anything, it merely snatches and has only three remarkable products; Tea, Whiskey and my books... the Tea is Chinese, the Scotch Whisky, I Irish..."


Meanwhile the English Commercial Court in the voice of Judge Sara Cockerill denied the Venezuelan government its gold and ruled in favor of the board appointed by Juan Guaidó, a ghost president. The undue and unusual appropriation of these reserves continues in London. It seems that British justice is "submitted, subordinated, gagged to the decisions of the British Crown" as Venezuelan Vice President Delcy Rodríguez declared.



An oil company intervened in the US: CITGO, created in 1965 in the US by Cities Service Company has been bought in 1982 by Occidental Petroleum Corporation. In 1986, PDVSA, the Venezuelan national oil industry, bought 50% of its shares and acquired the rest in 1990. It currently has more than 10,000 gasoline pumps and 2 refineries. It is a subsidiary of Petróleos de Venezuela, based in Houston to market oil, gasoline and oils. Because it is intervened by the United States, Venezuela estimates that it produces a monthly loss of 900 million dollars per month. As in the case of gold in England, taking into account the number of gasoline distribution companies that the US has, it seems that the real intention of this intervention is another, and not simply this commercial activity.



A plane Cargo hijacked in Argentina: It is a Boeing 747-300 Cargo of the Venezuelan state Emtrasur dedicated to the transport of freight detained with its crew (later or shortly released) at the international airport of Ezeiza, in Argentina since 2022. Emtrasur bought the aircraft from Iran's Mahan Air, but the U.S. alleges that U.S. law requires that sales of goods made with technology in this country, such as Boeing, must be notified. Despite the fact that the Argentine government opposes the delivery of this plane, the United States Justice intends to act for the Argentine Justice. In this case it seems that the purpose of the US, apart from creating other damages to Venezuela, is to demonstrate who commands more, that is, who is the "gendarme of the World".



Alex Saab

A diplomat imprisoned in the US: This is the Venezuelan diplomat Alex Saab, on an international mission visiting friendly countries to obtain supplies for the Venezuelan people of food, medicine and fuel for reasons of shortages due to the sanctions suffered by Venezuela. On the occasion of a stopover, in Cape Verde he has been arbitrarily detained in June 2020 in Cape Verde and in what resembled more a kidnapping than a legal extradition, the US imposed his transfer to Miami where he has been imprisoned since October 2021. Initially charged with nine offences, later reduced to just one of the nine. Alex Saab for the U.S. Attorney's Office for the Southern District of Florida — which

ruled out diplomatic immunity — retained a money laundering charge that carries about 20 years in prison if convicted. One more demonstration of who considers himself "gendarme of the World".

Almost a thousand unilateral sanctions imposed: These are just five examples among many more and within the framework of the almost one thousand sanctions imposed unilaterally by the US and its EU allies against Venezuela. They are basically sanctions to deprive the people of medicines, food and basic necessities that extend to other friendly nations that wish to trade freely with Venezuela. The objective is to create serious damage to Venezuelan citizens to destabilize the country and justify an intervention with the classic purposes of plundering mainly its natural resources and seizing its strategic geographical location.
