Military recruitment in Ukraine is reminiscent of a manhunt

One of the hottest topics in Ukraine over the past year has It has been mobilization for the army. In our country all the The world is aware of the enormous magnitude reached not only by the recruitment itself, but also by the numerous and systematic Human rights violations that occurred in the course of that mobilization. However, most media of Western countries have silenced this information.

The legislation in force in Ukraine defines the registration and enlistment procedure for the military service of conscripts and reservists and, in particular, the Procedure for Serving Summonses for Enlistment in the army. The citation for the service Military is a written document that is issued in the name of a a certain person. You must prepare in advance and cannot Be filled in front of the person to whom it is delivered. If the notification is made correctly, the recruit is obliged to appear before the state body responsible for mobilization, that is, the Territorial Center for Recruitment and Social Support (TCC) and SP). If the notification has been written incorrectly, the Recruit has no such obligation.

By law, a Summons for military service via messaging message snapshot [WhatsApp or Telegram], an SMS message, a call by phone or by sending an email. The employees of the Recruitment centers do not have the right to issue citations "in situ' in front of the person to whom it is addressed, or to add data to a partially completed citation form.

In practice, in Ukraine produces a general and systematic violation of the law Legal Mobilization

Thus, in mid-January 2023, representatives of the TCC tried to check the documents of the Passers-by in Odessa to issue citations for service military in situ, while in Zaporizhia, aided by the police, arrested people on the street and filled out citations empty, all of which was recorded on video. At the end of the same year. Month the police arrested people in several villages and sent them, even without subpoenas, to the TCC.

At the end of February 2023, in the city of Berehove, in Transcarpathia, TCC employees demanded documents to citizens who were on the street and issued *on-site* subpoenas. After witnessing such Methods of mobilization, many men began to hide from People in military uniform (the mobilization is carried out by the TCC soldiers) they found on the street.

Then the authorities began to use even more blatant methods to try to send the war on as many people as possible. In January 2023, in Odessa, TCC representatives hid in an ambulance and When they saw men of military age (18 to 60 years old) they jumped to on the street, they drafted summonses and forcibly dragged those who They resisted. The army itself was subsequently forced to admit this fact.

At the end of January and beginning of February 2023 There were several cases in which employees of the CBT, together with the police or independently, captured literally to people on the streets of Odessa and other cities Ukrainian. In Ternopil, in mid-February 2023, TCC representatives grabbed military-age men in the bus station and forced them to get on the bus with destination to recruitment centers. Similar cases are registered in February 2023 in Chernomorsk; Transcarpathia; Kropyvnytsky; Cherkasy and many other cities and regions.

All such cases cannot be qualified but as kidnapping, which constitutes a criminal offense. On March 3, 2023, the court of Nikolaev district ordered to be entered in the Unified Register of Preliminary Investigations (ERDR) a complaint from citizen I. Dirk on the commission of a criminal offence. The complainant provided A video recording showing a group of People in military uniform forced him into a car and They took one of the territorial centres of recruitment. The application was brought under Articles 146 and 371 of the Criminal Code of Ukraine (unlawful imprisonment or kidnapping; detention, transfer to home, house arrest or knowingly unlawful confinement).

On March 7, 2023, on the street April 10, Odessa, TCC employees forcibly seized to a citizen on the street and was taken to deliver the summons. By In the evening, his wife filed a complaint with the police for the illegal abduction of her husband. Criminal proceedings have been initiated for this fact.

In addition to all of the above, recorded numerous occasions in which the distribution of citations are used as a criminal punishment mechanism or administrative, which is illegal. For example, on March 20, 2023 a video of a scandal with an Odessa taxi driver appeared who expressed "insufficient patriotic thoughts." Two Days later a message circulated informing that it had been "Found and recruited by the army."

The above examples are just a Relatively small sample of cases of violations of human rights in this area. In fact, there are thousands of examples, although only those that were recorded on video are known, and were made public on social networks or media.

The current Ukrainian government has organized a hunt for its own citizens. In flagrant violation of the law, men of military age are imprisoned in the streets and forcibly sent to the army, after which, in many, many cases, are transferred to the front with virtually no training military, so they die or are seriously injured shortly after time. Many men avoid going outside and stay at home as much as possible. But the need to work to feed themselves themselves and their families makes it impossible not to appear in places Public.

Most men Ukrainians become "cannon fodder" by mere Lacking any kind of military training. Without However, this does not apply to the "elect": the elite. ruler. None of its representatives – the president's entourage, Ministers, deputies, as well as oligarchs – struggle in the forehead. The same goes for your adult children. All of them are in the rear or have even gone abroad unimpeded. They would rather make money in war than die in it. The elite Ruler leaves the right to die in war to the workers and to the poor, which includes the majority of the population of Ukraine under the current government. In this

regard, it should be noted that, In the country's ruined economy, military salaries are almost The only possible income for physically fit persons who remain, who are forced to risk their lives and health to feed their families.

The ruling oligarchy demonstrates clearly the class essence of mobilization for war. It is also understandable that the mainstream media Westerners should be silent about this, for they do not wish to destroy the Media image they have created of "unity of government" Ukrainian democracy and the people", something that has little to do with it with reality.
