

Late Zionist colonialism

That historical, proverbial hospitality of the Palestinians (in the nineteenth century), living with the Old Yishuv – with the immemorial Jews of Palestine, with whom they have no known conflict – was not destroyed by the Palestinians – Muslims, Christians or agnostics – but by the Zionists. With the New or Modern Yishuv. October 7 was another attempt, another "assault on heaven."



2023: After October 7, the Zionist ideology lives one of its moments of glory.

What Hamas and Islamic Jihad have done since October 7, 2023 (exactly 50 years after the outbreak of the Yom Kippur War, from Egypt against Israel), in the vicinity of the Gaza Strip, in nearby kibbutzim and surrounding cities such as Bersheva or Ashkelon, has been violent, with murders committed with cruelty; razing a festival, shooting people, kidnapping civilians (and military, which in a society as militarized as Israel's is sometimes difficult to distinguish). A sort of "invasion" with very limited material means; equipped the "assailants" with motorcycles, with hang gliders, all components more typical of a guerrilla than of a real army; A lot of resolution, "putting the body".

The "response" carried out by the Zionist state will be, and is already being, much more shocking, tenfold, hundredfold the victims among the Palestinians reached by the Israeli "fury" (through a mixture of military and material superiority, forged by Zionism in recent decades with a supremacist imprint that forged Zionism long before the Nazi persecutions of the '40s). The first Israeli air raid in response to the "invasion" of October 7, in the style of those carried out under the modality of mortal and collective punishments, on several occasions (2006, 2008, 2012, 2014, without the so-called "international community" has ever moved a hair), deploys a wave of simultaneous torture on hundreds of men, women, children, with shattered skulls, severed thighs, deadly hemorrhages, torn arms, disfigured faces; All included in merciless bomb attacks on buildings – not barracks – of civilian homes with bedrooms, dining rooms, bathrooms, inhabited by babies, the elderly, children, their parents, young people who play ball, who listen to music.

Genocide in stages, with silence expected from the UN, but also from many independent, autonomous networks (nobody wants to appear as anti-Semitic).

The IHRA's carefully constructed version of the Holocaust, [2] which would guarantee Jews the right to be unsuspected, because of their basic status as victims, is simply an alibi. Beyond what Jews actually suffered under Nazism. Because, as the historian, Jewish, with victims of Nazism in his family, Norman Finkelstein, has defined: "it is an ideological representation of the Nazi holocaust. Like most similar representations, this one has a connection, albeit tenuous, with reality." [3]

In short, Israel and those who wield its power play their trick: to present themselves as victims when they are the ones who "produce" the most victims. Israel is the great generator of madness, misery and death among Palestinians. Because colonialism, racism, have always generated the above and also resistance. Abya Yala in the Eastern Mediterranean

Let's try to broaden the angle: Zionism does to the Palestinians what the European conquerors did in Abya Yala, known for how it was renamed by the newcomers: America. Here is a portrait of Miko Peled, an Israeli Jew, but unlike the vast majority of his fellow citizens, with a critical conscience (or if you prefer, self-awareness):

"Racism and violence against people of color in America is nothing new. In fact the US, with its claims to [be] "the land of the free" has always been a racist, genocidal and violent state. It was founded on the genocide of the natives and on the backs of African slaves. The U.S. committed the most heinous war crimes in human history, including genocide, the use of nuclear weapons, the destruction of democracies, and supporting murderous dictators around the world. And the list goes on from the earliest days of the Union to today." [5]

What is significant is how Jewish Zionists identify with the U.S. and how they seek to follow the colonialist path of the seventeenth, eighteenth, nineteenth centuries of the United States, in the twentieth (and twenty-first) centuries in Palestine. A little out of time, as if ignoring "the new time" that became from 1945, precisely from the United States.

It is a peculiar model, however. Because while "inspired" by the treatment of "inferior" or "immature" races in the US to carry out its policy of implantation in Palestine, Israel has sought to exert the greatest imaginable infiltration of American society, with which the ligament between the US and Israel is twofold: the American country is visualized as a

"father" or model figure. and at the same time as an entity that would receive the "benefits" of all Jewish contributions. I quote Peled again: "There are countless areas in U.S. life in which Israel and various Zionist organizations influence and interfere. The Jewish Federation, the Anti-Defamation League, and AIPAC are the most commonly recognized, but they are just three of the countless organizations operating in all fifty states and relentlessly pursuing Israeli interests in all facets of American life. These organizations interfere in U.S. elections by investing money in the campaigns of pro-Israel candidates." (ibid.) We are talking about a substantive and decisive financial contribution in decision-making.

After the blowing up of three New York towers – the twins and one more, all for the price of two planes and thousands of fatalities – and the peculiar hole in the Pentagon on September 11, 2000 (with its thirty dead), and despite the immediate roundup of hundreds of Israelis under suspicion by US security agencies (there were more Jewish detainees than Arabs in the following hours). since *September 11, many U.S. police forces* [are] *trained by Israeli security experts."* (ibid.)

Analyzing Israeli-Jewish penetration in the U.S., James Petras pointed out that among the many "Zionist projects with considerable funding, made to capture young Jews and turn them into instruments of Israeli foreign policy [is] "Taglit-Birthright" which has spent more than \$250 million over the past decade sending more than a quarter of a million Jews to Israel during 10 days of intense brainwashing.[...] Students are subjected to a heavy dose of Israeli-style militarism [...] as part of their indoctrination; at no time do they visit the West Bank, Gaza or East Jerusalem (Boston Globe, 26 Aug 2010). They are urged to become dual citizens and are even encouraged to serve in the Israeli armed forces. [6]

Race and sex

If we realize the kinship between the "conquest of America" and the AngloZionist colonialist project in Palestine, something postulated and promoted by well-known Israeli leaders, we can perceive more clearly the destiny attributed to conquerors and colonized. "The only Indian that counts is the dead Indian." That atrocious expression of the collectors of hair of murdered Indians translated in the nineteenth century a very modern chrematistic turn, because the authorities (public or private) paid for hair. A practical way to ensure "territorial clearance": the task carried out by the Rosas and Roca in the Argentine pampas; the Riveras in the territory of Uruguay. That "trade" fulfills one of the sacred laws of privilege: the reversal of truth. Because "adventure stories" for children

have always taught that Indians were hair hunters (and not for pay, but for their innate cruelty).

Analogous to the "ethnic cleansing" that we have known for centuries in the Americas, we have, for example, the testimony of Israeli soldiers, who have declared – we do not know if out of intellectual honesty or *chutzpah* – that they have no difficulty, procedural, judicial, if they kill a Palestinian. If they add a head of hair to their service sheet.

Spaniards and English had different behaviors with the natives. The English rejected that mixture of blood (which comes after the mixture of sexual juices). The Spaniards also, in the case of male Indians with Hispanic females, but in no way rejected the contact of Spaniards with "Indians". So, to understand the latest developments of the "Israeli-Palestinian conflict"; Hamas unloading a barrage of more or less improved Kassam rockets; abducting Israeli civilians and military personnel; An enraged population victimizing Israelis taken hostage, we must visualize these barbarities together with those unleashed with impunity by Israeli settlers or soldiers on unarmed peasants, on young people or children who throw stones, on young girls who brandishing a scissors want to hurt some occupant and are killed without further ado. Year after year, month after month, day after day.

Let's remember that when in 2019 Marches for the Earth begin, without weapons, without stones, just claiming that; Land (increasingly cut off and appropriated by Zionists), the Israeli security apparatus "answers" with snipers who from a distance and comfortably lodge bullets in the groins of peaceful demonstrators.

Since those hit began to die with unexpected frequency, bleeding to death, the Israeli command changed the order to the comfortable (and well-trained) snipers: not to the groin but to the ankles. They left resentments for life, but they did not produce the psychic disorder and the consequent repudiation of so many murders by demonstration.

That is the value of Palestinian life in Israel, as we are reminded by sincere soldier testimonies. So it must be understood that many Palestinians also end up despising the lives of Israelis.
