## Zionist Holocaust and Urgent Calls for the International Criminal Court

Both IHL and the Rome Statute define international crimes as grave violations of the laws and customs of war, as well as acts committed as part of a widespread or systematic attack against the civilian population.

These definitions are fundamental for international justice and call for the concentration of forces, efforts and initiatives of popular mobilization and legal argumentation, to convene without delay the International Criminal Court, to establish a tribunal that fulfills its mission of pursuing, investigating, judging and punishing the Netanyahus and other perpetrators who, in the face of the impotence of the world, commit such crimes.

The State of Israel, victim of the first Nazi holocaust, now recreates and stages the execution of a final solution against the Palestinian people. He has violated the canons of the human condition in the name of vengeance, setting the stage for "the second holocaust in recent history", this time carried out by the military forces of the Zionist regime of Israel, who, in just 30 days, have overcome the first phase of the Nazi horror, against their people, whom they represent, Thanks to this, he was re-elected, not exactly to activate barbarism, which far exceeds the rules of war.

The first rule of IHL states that the occupying state (Israel, as it has long been used in UN resolutions, condemning the occupation and violence against the Palestinian people) in order to be able to legally defend its strategy against its opponent, must clearly distinguish between combatants and non-combatants and between military objectives and protected property. The figures collected by dozens of journalists, agencies, news, have accounted for more than 11,000 deaths, of which 3500 are murdered children and more than 4000 are women, the elderly and the sick. Infrastructures of protected property, cultural centers, places of worship, museums, libraries, schools, hospitals, medical transport vehicles, totally destroyed, literally turned to dust, ruins mixed with hundreds of mangled bodies. Medical missions attacked, journalists murdered, streets, houses, offices, shelters, canteens, all razed to the ground in a rake operation, to make more cruel and relevant the damage and derision caused by the Israeli "heroes", exalted by the protective government of the United States (which has never ratified the Geneva Conventions, nor recognized the courts of international justice) and, hired for their "experience" and ability by governments in other latitudes to advise and encourage internal wars.

Confiscation, obstruction and denial of access to basic basic services, water, food, medicine, electricity, communications, implies violence against human beings and transgresses the rules of war, they are war crimes, in order to "avenge" to the point of extermination not of the fighters of the Al-Aqsa Brigade, belonging to the Hamas fighting militia. They were not the participants of the Gaza government in Palestine, which attacked them, but of the entire unarmed civilian people.

IHL limits the exercise of power by states and their rulers and military commanders to wage war. In a democracy, there are faculties, competencies and rules in force that require compliance without delay, in order to prevent it from being assaulted by tyrants, avengers or madmen. The rules of war, although they allow time limits to be placed on human rights related to free movement and in general to civil and political rights, and although war is in itself the antithesis and negation of human rights, those that represent its hard

core, such as life and human dignity, cannot be set aside by virtue of any state or government. When this happens, society, civilization, is faced with an exercise of terrorist power by the State, which resorts to brutal tactics such as murder, torture, arbitrary detentions, defends its extremist ideology and foments violence through its propaganda and official discourse, undermines the stability of the region, creates conflicts in the region and puts the entire planet at risk of war and nuclear threat. Here the controversy over the terrorist state is sealed with the high government's calls for total destruction or even to give itself the opportunity to drop an atomic bomb.

Israel as a State cannot claim or justify self-defense, nor the right to defend itself. After 30 days of extreme cruelty, the plan and its express intention of extermination and systematic aggression turn every act of unbridled force into an act of barbarism and this barbarism into its climax of madness and avenging folly. it must be urgently condemned by any state and government that claims to be democratic, and judged as an international crime in its variants of genocide, war crime, crimes against humanity or aggression under the Rome Statute and the jurisdiction of the ICC.

A month has passed since the Holocaust and the rich world does not stop calculating, companies are doing well, the accumulation of capital is becoming more and more concentrated and the G-7 meeting in Tokyo through the foreign ministers, barely touched on the subject to make the "strange proposal" to promote "humanitarian pauses", without a ceasefire. nor rejection of the ongoing barbarism, which has despised every moral and intellectual value of the human being. Organized brute force in all its might against human life has mercilessly attacked and promoted national hatred against the Palestinian people, stigmatizing them, inflaming the feeling of hostility and killing, simply killing with viciousness. In one month, figures announce that a child is killed every 10 minutes and two more are injured, exposed, without medical missions, water, electricity and medicines. It is time to believe that the warriors have overcome their hostile feelings and have entered a phase of extreme brutality, severe emotional maladjustment, revenge and revenge that they feed with the pain and smell of blood of their victims. It is time for the sense of humanity of the peoples of the South to raise their voices and rage against the colonizer, to add to the resistance that has always accumulated, and for the South of each North to articulate capacities for the ICC to begin to judge.
