### **The NDFP Condemns the Unjust Trial**

#### **of the 12 Italian Comrades of CARC, ASP and nPCI**

On May 13, 2008, twelve (12) leaders of the Party of Support Committees to Resistance for Communism (CARC), the Association for Proletarian Solidarity (ASP) and alleged leaders of the New Communist Party of Italy (nPCI) are facing trial on the spurious charge of "subversive association with the aim of terrorism". The National Democratic Front of the Philippines (NDFP) condemns the Italian authorities for staging this mockery of justice and extends its solidarity and support to the accused comrades.

For more than twenty years the reactionary Italian state authorities have carried out political repression against the "caravan" of the nPCI through surveillance, house searches, sequestration of materials, theft of money, threats, and preventive arrests.

The CARC and the ASP leaders are being put on trial because they are Communists and have openly declared to support the project of the nPCI to make Italy a new socialist country. They have also been active in arousing, organizing and mobilizing the masses of workers and other toiling people in Italy. They have been active in the popular movements No Dal Molin (against the Nato base in Vicenza) and NO TAV (against the High Speed Trains) and against the continuous dismissals of the most militant workers in FIAT of Pomigliano and FIAT Sata of Melfi. Their leaders were also at the forefront of the protest actions on the issue of garbage in Naples and in all Campania.

This action of the reactionary state authorities follows the trend towards fascism in many imperialist countries as a result of the grave socio-economic crisis afflicting the world capitalist system and the growing restiveness and resistance of the workers and other toiling masses. The present crisis is the worst since the end of World War II. The imperialists themselves, including their ideologues and propagandists, admit that the current conditions of global recession generate social unrest and political turmoil.

The conditions of socio-economic and political crisis in the advanced capitalist countries are worsening and are pushing the working class and the rest of the people to rise in resistance. Millions of migrant workers have also risen up against the criminalization and harsh conditions that they suffer. The workers and other toiling people are rising up against the loss of job tenure, the decrease of jobs, the reduction of incomes, the lack of pension, health insurance and other social benefits and the continuing erosion of workers' rights. The monopoly bourgeoisie are increasingly hard put in devising new ways for deceiving and appeasing the people. More and more the monopoly bourgeoisie are turning to fascist measures to oppose the mass movement of the proletariat and non-proletarian masses.

The monopoly bourgeoisie have used the so-called threat of terrorism as a pretext to take repressive measures and enact repressive laws against Communists and progressive activists whom they consider as the long-term threat to the capitalist system of oppression and exploitation. Many European states have followed the lead of the US in enacting laws similar to the USA PATRIOT ACT and putting up arbitrary terrorist listings. In Europe, right wing parties have tried to initiate a campaign for the outlawing of Communism and Communist parties.

The political persecution being perpetrated by the reactionary Italian authorities is part of this trend to fascism developing in many capitalist countries as a result of the general crisis of capitalism. This trend must be exposed and firmly opposed by all progressive people and those who uphold democracy.

We are deeply outraged about the fact that the notorious judge Giovagnoli has summoned 12 comrades in Bologna for 13 May 2008 for preliminary investigations for a trial, among them Guisepe Maj and Guisepe Czeppel from the (new) Communist Party of Italy (nCPI), and a number of leading members of the party CARC.

They are accused of „*subversive organization*“ (according to §270b of the Italian criminal law) because they have allegedly “*promoted and participated in the founding of (n) CPI .*”

The ruling powers in Italy are afraid of the consolidation and higher development of the working-class and people’s movement and of the strengthening of the Marxist-Leninists who are struggling for a socialist perspective. That is the reason why they want to criminalize any attempt to build up a new communist party.

This is being justified with the absurd lie that the accused persons supposedly have “*terrorist goals*”. This is in line with the declaration of the EU-Council which declared Marxism-Leninism to be the “*real cause of terrorism*” with the aim of criminalizing Marxist-Leninist organizations on this basis.

We are certain that you will even intensify your efforts to spread genuine socialism among the working class and the broad masses of people in Italy. It is exactly the right response that you organize broad resistance against this oppression. We are with you at your protest demonstration on 13 May in Bologna and wish you every success!

### **Declaration of Solidarity**

**fo the immediate stopping of the criminal proceedings against members and sympathizers of the CARC Party, the (new) Italian Communist Party and the Association for Proletarian Solidarity**

On next 5<sup>th</sup> November in Ancona (Italy) it will be held the preliminary hearing for the Tenth Judiciary Proceeding the Italian Authorities framed up against the “caravan” of the (new) Italian Communist Party. The public prosecutor Marco Pucilli of Ancona leads the inquiry. Comrades of the Party of the Committees to Support Resistance -for Communism (P- CARC) and of the Association for Proletarian Solidarity (ASP) are charged with “slandering the Public Prosecutor Paolo Giovagnoli”, because they called him with his true name, the “new Torquemada”.

The judiciary proceeding the Public Prosecutor Marco Pucilli frames up goes with the appeal to the Supreme Court the judge Giovagnoli did against the “non – suit” judgement of the Judge for the Preliminary Hearings Rita Zaccariello on 1<sup>st</sup> July. Also the General Attorney of Bologna did an appeal as regards the matter, and this is a deed absolutely exceptional and extraordinary.

The many judiciary inquiries against who has worked for the (n)PCI, against the CARC Party, the Association for Proletarian Solidarity and their sympathizers and helpmates are a clear violation of any democratic principle. They are an attempt, by now no more too much concealed, to outlaw Communism.

The Joint Coordinating Group (JCG) of the International Conference of Marxist Leninist Parties and Organizations expresses its solidarity, condemns the ongoing repressive action and demand the immediate stopping of the proceedings.

The JCG takes the opportunity to declare its solidarity with Paolo Babini, representative of the current main coordinating organization in the JCG itself, the CARC Party, Italy, who is among the comrades against whom the appeals to the Supreme Court by the judge Giovagnoli and the Bologna General Attorney are conducted.

We condemn and contend such repressive actions as they are expressions of an anticommunism increasing in the imperialist countries, aimed to deny the freedom of propaganda and organization the Communists conquered and expression of the aim to restore the reactionary and fascist regimes that the Communists and the people's masses fought and won paying with their lives.

The ruling power in Italy are afraid of the consolidation and further development of the revolutionary and the working class and people's movement and of the strengthening of those forces who are struggling for a socialist perspective.

The struggle against “Anti-terror” slander and anticommunism affords the organizing of a broad movement for the struggle to maintain and extend democratic rights, and to inform the broad masses about these proceedings and to build a bulwark against any further actions.

We consider this and any other repressive action against any participant in the Conference as an attack to the Conference itself, and as such we are committed ourselves to oppose it.
